Building on years of successful teamwork between CalWORKs and Child Welfare, Linkages 2.0 brings the strength of collaboration to child maltreatment prevention. Seeking to interrupt the increased family stress and risk for maltreatment that comes with poverty, Linkages 2.0 supports county efforts to provide primary, secondary, and tertiary prevention via concrete supports and family strengthening services for CalWORKs families and coordinated services for families mutually served by CalWORKs and Child Welfare.

Child Welfare Services and CalWORKs serve many of the same families, yet too often there is limited coordination, communication or resource sharing between the two programs. Parents face the complexity of negotiating multiple systems with conflicting requirements and timeframes – while counties lose the opportunity to leverage resources and provide needed supports to better serve families.

Counties across California are coming together to implement strategies and activities to improve collaboration between CalWORKs, Child Welfare Services, and communities – collaboration that improves services as well as the program bottom line.
