




Overview and History

Linkages Background

- 2000 Started collaboration between Child Welfare and CalWORKs
- Service coordination for families with open Family Maintenance or Family Reunification cases
- How did it work?
 - Development of a process for early identification of mutual families
 - Active collaboration between CW and CalWORKs staff
 - Co-location
 - Attendance at CFTs
 - Mutual trainings



Linkages Timeline



Legislation Supporting Collaboration

 AB 429 – Allows continuation of CalWORKs services for the parent or parents of children who have been removed from the home. If the county determines that services are necessary for Family Reunification (FR), AB 429 provisions allow the parent(s) to receive CalWORKs Welfare-to-Work (WTW) Supportive Services (i.e., WTW plan), substance abuse, and mental health services, if it is determined that such services are necessary for family reunification.

- AB 135 Authorizes the provision of cash aid and childcare services to families participating in CalWORKs Family Reunification (FR) as part of their reunification plan for up to six months.
- CalWORKs families receiving FR services now eligible for continued cash aid and childcare services for up to six months (ACL 23-94)
- Improved collaborative technology increased efficiency and improved information sharing

Intersection of Economic Hardship and Child Maltreatment


- Families facing poverty, unemployment, or housing instability are more likely to experience stressors that can lead to child maltreatment (CDSS 2019-2020)
- Economic hardship can contribute to parental stress, mental health issues, substance misuse, and inadequate access to healthcare, all of which are risk factors for child maltreatment (CDPH "Adverse Childhood Experiences and Health Outcomes in California")
- Addressing economic inequality and providing targeted support to families in need are essential strategies for preventing child maltreatment and promoting child well-being in California (Public Policy Institute of California)


Child Welfare Services: Emergency Response

- Investigate allegations of abuse and neglect
- Assess for safety and risk
- Identify family strengths and needs
- Provide interventions to enhance safety and mitigate risk




Equity and Inclusion



Equity and Inclusion

- Address the systemic disparities Black and Native American families face in Child Welfare programs.
- Cultivate and maintain meaningful relationships with tribes.
- Empower families, tribes and community networks.
- Ensure access to, and support use of, well-being and healing practices that are relevant and meaningful to the family and its culture.




The assumption is that everyone benefits from the same supports. This is equal treatment.



Equity

Everyone gets the supports they need (this is the concept of "affirmative action"), thus producing equity.

Justice



All 3 can see the game without supports or accommodations because **the cause(s) of the inequity was addressed**. The systemic barrier has been removed.


