COLLABORATION OPPORTUNITIES

Counties serving families receiving CalWORKs FR cash aid are encouraged to use the CWS FR case plan or the Linkages case plan and to include activities or services provided by CalWORKs in place of the Activity Assignment (WTW 2).

Doing so will increase families' ability to reunify by eliminating conflicting requirements. If additional activities or services not included in the CWS FR case plan are required, use the WTW 2 alongside the CWS FR case plan.
